### 1 Introduction

In the context of the preparation for the third reference period (RP3) of the Single European Sky (SES), EUROCONTROL/PRU gathered a number of evidences in order to support the Performance Review Body (PRB) in the establishment of the RP3 EU-wide targets (see the document *D412 – EUROCONTROL evidence for establishing the EU-wide RP3 targets*, dated 17/05/2018).

One of the evidence described the historical development of costs expressed in €2009 while another one presented the forecast costs and traffic figures for the period 2020-2024, which were provided by Member States to the European Commission (EC) in May 2018.

On 17 December 2018, the Single Sky Committee (SSC) gave a positive opinion to the new Regulation setting up a performance and charging scheme for the Single European Sky (the Performance and Charging regulation). This Regulation introduces a number of changes in the way Determined Costs have to be calculated (in particular by using a €2017 inflation index basis and by applying different inflation rules).

On 17 December 2018, the EUROCONTROL PRU submitted a short report presenting the actual and forecasted en-route cost series provided by Member States to the EC in May 2018 for the period 2012-2024, recalculated based on the new rules concerning the application of the inflation adjustment and expressed in real €2017 terms¹. This report was subsequently updated on 9 January, 18 January and 19 February 2019.

These recalculated costs series were used as basis for the bilateral meetings organised between the EC and Member States in January and February 2019 with the view to get local inputs for RP3 EU-wide target setting. In this context, a number of Member States<sup>2</sup> provided the EC with revised and up-to-date costs series for the period 2018-2024.

This version 2.1 of the report submitted by the PRU of EUROCONTROL presents the up-to-date cost series based on the latest submissions by Member States.

# 2 Methodology

Based on the provisions of Article 2(11) & (12) of the new Performance and Charging Regulation, both the nominal actual cost series for the period 2010-2017 and the forecast costs series for the period 2018-2024 have been converted in real terms through an inflation index which uses 2017 as reference year (i.e. 2017 becomes the basis for the computation of the inflation index instead of 2009, as it was the case during first and second reference periods).

Additionally, according to the same Article, in case of deflation (i.e. planned inflation rate below zero) during the period 2018-2024, the yearly percentage change in inflation was capped to zero.

Furthermore, in line with the provisions at Article 22(2) and Article 26 of new the Regulation, the conversion of actual and forecasted costs from nominal to real term values only applies to ANSPs' and MET providers' operating costs (i.e. staff and other non-staff operating costs, including also exceptional items), but does not apply to capital related costs (depreciation and cost of capital) nor to NSA/EUROCONTROL costs, which therefore are expressed in nominal terms.

### 3 Results

<u>Table 1</u> below presents the up-to-date en-route cost series based on the latest submissions by Member States in the context of their bilateral discussions with the EC. These series (converted in EUR common

currency using the 2017 actual average exchange rate as published by the CRCO for charging purposes) are based on the new 2017 inflation index basis and computed according to the new inflation methodology described above.


